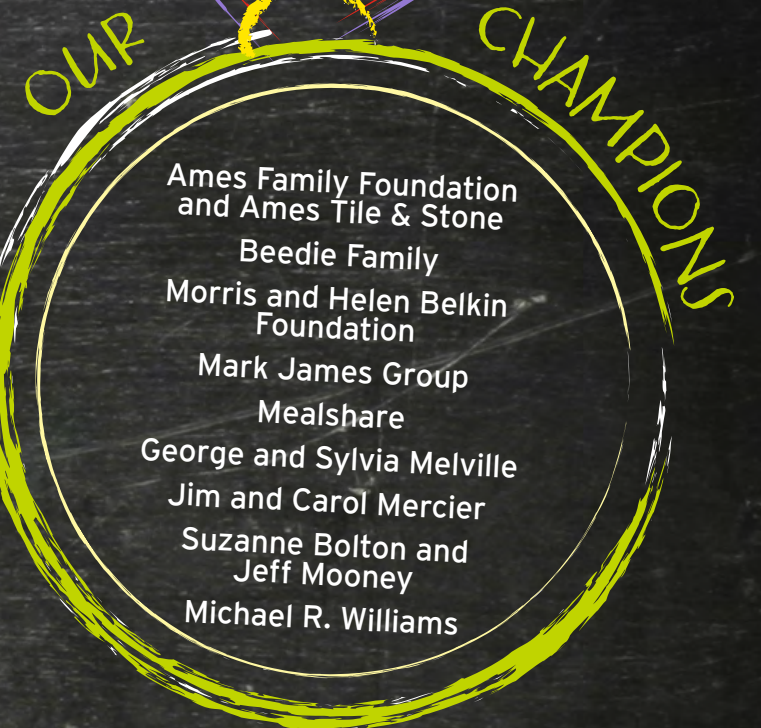

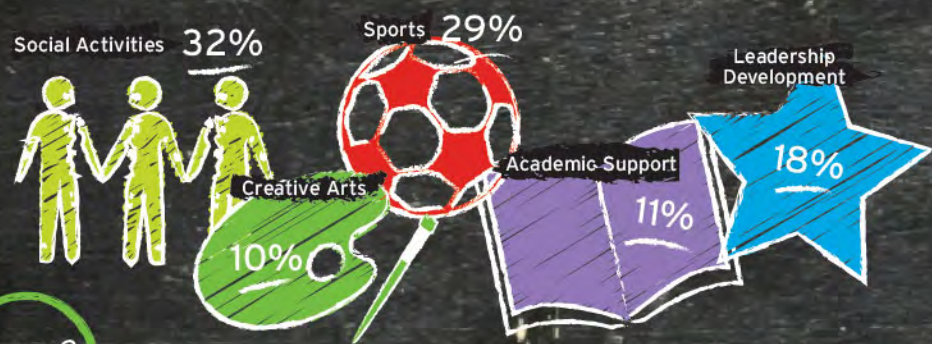

17¢

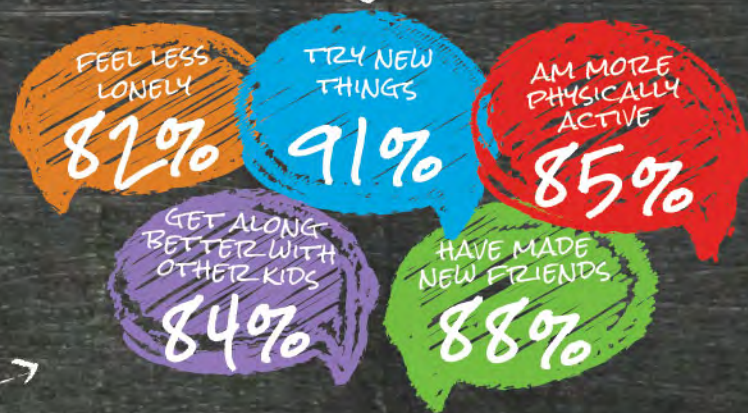

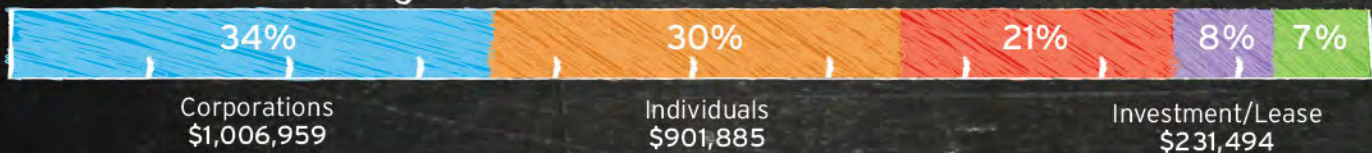

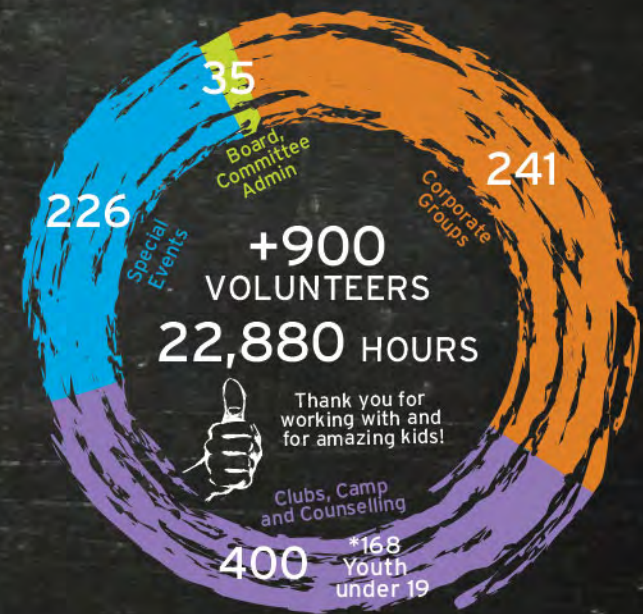
