Over this past year, we embarked on an extensive process to develop a new Strategic Plan that will guide us into the future. While we're still working out the fine details, we know that this clarity will result in an expansion of **Membership** in many forms, including new Clubs, expanded programs and services, and new ways for kids, families, and the community to "belong" to Boys and Girls Clubs. We look forward to your thoughts on how we do that, so we hope you'll stay close as we move ahead.

From a financial perspective, it's important to report that BGC has received an unqualified audit opinion from Grant Thornton LLP with respect to the financial statements for the year ended March 31, 2013, which were prepared in accordance with Canadian accounting standards for not-for-profit organizations, and we feel that we are in a strong financial position. The Board is continuing to focus on governance, to ensure that our children, youth, families, and communities can continue to rely on a well run, solid Boys and Girls Club for support. Among the highlights of 2012/13 were the opening of two new facilities for our Langley and Surrey Clubs (supported most notably by BGC Foundation of South Coast BC, R. Howard Webster Foundation, Rotary Club of Langley Central, and the Jays Care Foundation) where **Membership** has already expanded significantly as a result.

We extend our sincere thanks to all who support and participate in our work: from dedicated staff and Board, Government partners, the BGC Foundation and their donors, to our community service partners with whom we collaborate to deliver the best possible programs and services for our kids and families.
