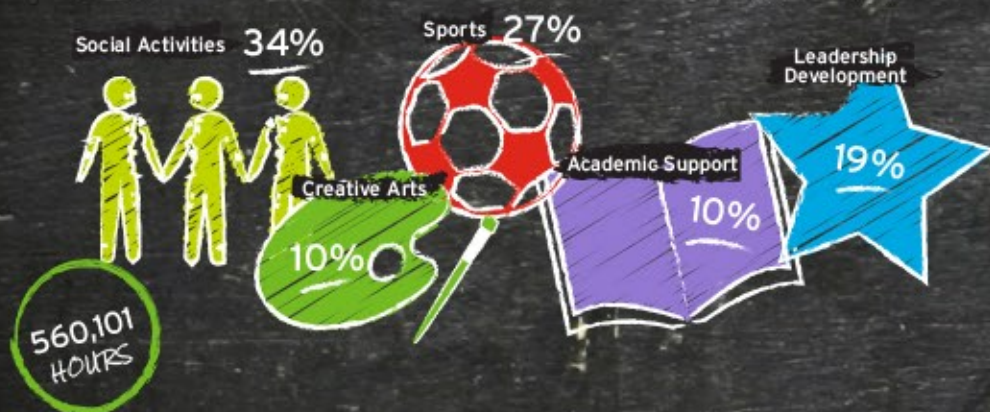

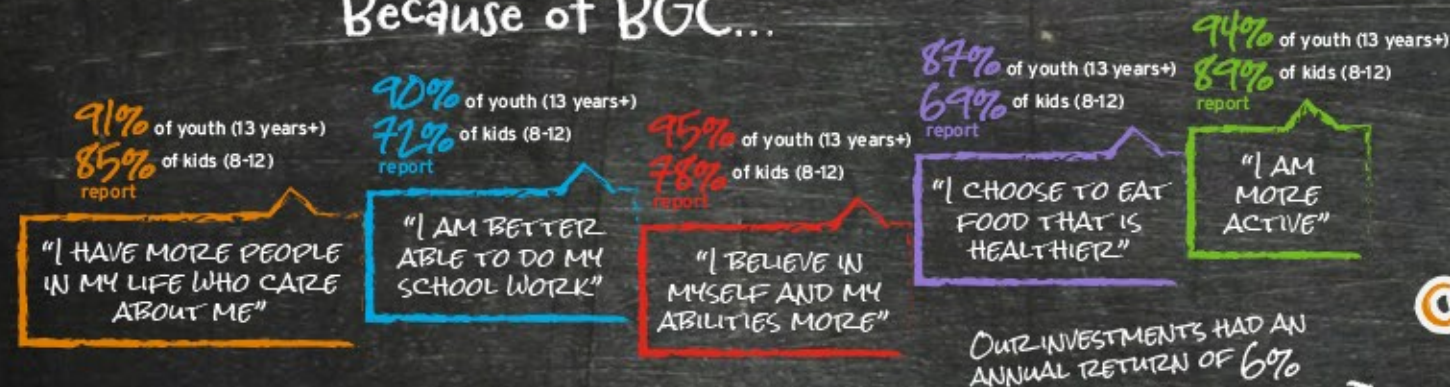
How Kids Spend Time in our Clubs
