This year, we were *aaaall* about sharing the WHY behind the way that we do things here at BGC. We focused on telling the truth about how we create safe spaces for kids and youth, and how these "BGC truths" guide everything we do. Here's the low-down:

BGC Truth #1 — We bravely use strengths-based, positive language when we talk about our kids, youth, and our families, even though it makes our work harder.

We see kids for who they REALLY are, which is FULL of potential. That can make our job harder because there are a lot of people out there who want (or might even need) to hear the sad stories and the difficult things kids go through before they support us.

BGC Truth #2 — We believe everyone is trying their best.

We don't ask or require families to prove that they need financial help because that can cause harm, shame and trauma. We know that all families need support, one way or another.

BGC Truth #3 — BGC is for EVERY kid.

All kids and youth get an incredible experience at BGC, whether their families pay nothing, a little or 'full price'. Club Kids/Youth get to choose how they spend their time at Club from a HUGE variety of developmentally appropriate and fun options.

Because of these truths, we see AMAZING and POSITIVE changes in kids every single day.
